COVER LIMITS (€)

Please review the policy wording for full information on the coverage of this policy.



HOSPITALS

All Public, Private and Specialist Hospitals, including private and semi private rooms. A limit of €2.5m applies under this section of cover.



INPATIENT & OUTPATIENT TREATMENT

Cover for necessary Inpatient & Outpatient treatment including emergency treatment. A limit of €2.5m applies under this section of cover.



DOCTORS & MEDICINE

Cover for General Practitioner, Doctor or Specialist Doctor visits along with necessary prescriptions and medication. A limit of €2.5m applies under this section of cover.



EMERGENCY DENTAL

Cover for Emergency Dental Treatment required which is necessitated by bodily injury. A limit of €500 applies under this section of cover.



REPATRIATION

Unlimited cover for Repatriation due to serious illness or death. This also includes a limit of €7,000 for a round trip for a family member to be with the policyholder in the event of a serious illness or injury.



SCHOOL CLOSURE COVER

A commitment to ensure you complete your course in an alternative school should your school close or a refund of your course fees paid if this is not possible.



PSYCHOLOGICAL COUNSELLING

Counselling treatment in the event of a) the death or disappearance of an Immediate Family Member, Classmate or Roommate; or b) sexual assault and/or serious physical assault which has been reported to police.

An excess of €100 per claim applies under SECTION A: Medical and Other Travel Expenses



Any Pre-Existing Conditions, Criminal Acts, Cosmetic Treatment, Preventative Treatment, Dental other than Emergency, Hazardous or Winter Sports, Drugs/ Alcohol, Suicide or Self Inflicting injury, Precautionary/Check Ups, Acupuncture, Gradually occurring injuries (Repetitive strain), Withdrawal from course for personal reasons
