Academic Year Work and Study	<ul style="list-style-type: none"> <li>➤ The Academic Year programme includes 25 weeks of tuition, an exit exam and an 8-week holiday over an 8-month period. In total students may study for a total of three consecutive 8-month programmes over a 24-month period once they pass an exit exam each time.</li> <li>➤ All Academic Year students are obliged to sit and end of course exam.</li> </ul>
Calendar	<ul style="list-style-type: none"> <li>➤ ELI Schools operates an Academic Calendar with four 12-week Terms per year.</li> </ul>
Key Contacts	<ul style="list-style-type: none"> <li>➤ A list of Key Contacts for all departments in all schools is provided in the Student Handbook.</li> </ul>
Code of Conduct	<ul style="list-style-type: none"> <li>➤ All staff and students are required to respect and comply with our <a href="#">Code of Conduct</a>.</li> </ul>
Books	<ul style="list-style-type: none"> <li>➤ We include the cost of one course book in the material fee.</li> <li>➤ If students change class/level, they will need to buy a new book at the cost €35.</li> </ul>
Holidays	<ul style="list-style-type: none"> <li>➤ There are no holidays allowed on courses of 12 weeks or less.</li> </ul>
Academic Year Program Holidays	<ul style="list-style-type: none"> <li>➤ This programme includes 8 weeks of holidays within an 8-month visa.</li> <li>➤ There are strict rules on holidays that ELI Schools are required to enforce.</li> <li>➤ Holidays with a minimum duration of 2 weeks can only be taken after 6 weeks.</li> <li>➤ Students can only take a holiday that is equal to 1/3 of the tuition period completed.</li> </ul>
Putting a course on hold	<ul style="list-style-type: none"> <li>➤ In exceptional circumstances ELI Schools may allow a student to put a course on hold.</li> <li>➤ In the case of medical illness, a medical certificate must be supplied.</li> <li>➤ Flight confirmations must be supplied for all non-EEA students departing the program.</li> <li>➤ Accommodation, books, medical insurances will not be held if the program has started.</li> <li>➤ Tuition and exam fees only will be held for 12 months.</li> <li>➤ Credit for tuition weeks not used will be applied to a future booking within 12 months.</li> </ul>
Sick leave	<ul style="list-style-type: none"> <li>➤ If a student is too sick to attend school, they must inform the Academic Manager by email.</li> <li>➤ The student must provide a doctor's note to certify any sick leave.</li> <li>➤ All certified sick leave will not positively or negatively affect a student's attendance rate.</li> <li>➤ All uncertified sick leave will be recorded and will negatively affect a student's attendance.</li> <li>➤ Students must send all sick leave certificates to the Academic Manager by email.</li> </ul>
Attendance	<ul style="list-style-type: none"> <li>➤ All Non-EEA students are required to attend a minimum of 85% of classes.</li> <li>➤ Teachers are issued with a new class register every Monday. Class lists will be published.</li> <li>➤ It is the student's responsibility to notify management if their name is not on a class list.</li> <li>➤ It is the student's responsibility to notify the teacher if their name is not on the register.</li> <li>➤ Teachers record attendance 15 minutes after the start of class, break and before the end.</li> <li>➤ Students are expected to arrive to class on time and only depart the class at the end.</li> <li>➤ Students who are persistently late for class may be marked as absent for the period.</li> <li>➤ Registers are submitted daily, and records are updated in the school management system.</li> </ul>
Attendance Warnings	<ul style="list-style-type: none"> <li>➤ Every four weeks Academic Management will run reports on attendance.</li> <li>➤ Any student whose attendance is below 85% after four weeks will be issued First Warning.</li> <li>➤ ELI Schools submits a record of updated warning status to GNIB every four weeks.</li> <li>➤ If a student fails to improve their Attendance, they will be issued with a Second Warning.</li> <li>➤ If a student fails to improve their Attendance, they will be issued with a Third Warning.</li> <li>➤ The Third Warning is a Final Warning. The student is required to speak to a manager.</li> <li>➤ If absences continue or no medical certs are supplied an Expulsion Notice will be issued.</li> <li>➤ Students have five days to respond to an Expulsion Notice before GNIB is notified.</li> </ul>
Working Entitlement	<ul style="list-style-type: none"> <li>➤ Students are entitled to work 20 hours per week throughout their course, and full-time from June to September, and 15<sup>th</sup> December to 15<sup>th</sup> January</li> </ul>
GNIB and IRP	<ul style="list-style-type: none"> <li>➤ It is the student/ETO responsibility to book an appointment with GNIB within 90 days.</li> <li>➤ Students studying in Dublin must apply for an appointment online.</li> <li>➤ Students in Limerick apply for an appointment by email.</li> <li>➤ Students studying in Drogheda will have an appointment arranged for them.</li> <li>➤ Students will need to prove access to €4,200 in a recent bank statement.</li> <li>➤ Students need to pay €300 by card at the time of the appointment.</li> <li>➤ Your IRP card will be sent to your Irish address within 7 days.</li> </ul>
