Data Privacy Policy & GDPR

LT Education Abroad Limited. ("LT Education Abroad Limited.", "English Language Schools", "we", "us" or "our") provides users with the ability to investigate the process of becoming a student in certain schools around the world, including information about visa applications. and program information. We also provide the ability to apply for admission to certain programs of such institutions through our recruiting partners, counsellors, and our website and to access ancillary services and products related to the international student travel (collectively, the "Services").

To do this, LT Education Abroad Limited collects your personal data. This Privacy Policy sets out how LT Education Abroad Limited. collects, uses, discloses, and manages personal data. Changes made to this Privacy Policy will take effect on the date indicated above and your continued use of the services and / or the LT Education Abroad Limited website. after this date you will be subject to our updated Privacy Policy.

General

In this privacy and cookie policy, we describe:

- The information we collect and process about you (that you provide to us directly or are provided to us by third parties, such as our recruiting partners and consultants).
- The purposes for which we collect and process information about you.
- The basis on which we collect and process information about you, when you use this website located at <https://elischools.com/> (our "Website") and the services available through this website, provided to our registered users (collectively, our "Services").

In this Policy, the term "personal data" or "personal information" means personal data or data that relates to an identified or identifiable person. We recommend that you read this Policy carefully to understand what LT Education Abroad Limited. and its affiliates and / or subsidiaries do with your personal data. Your use of our website and services, and any dispute over privacy, is subject to this Policy and any of our applicable Terms and Conditions for the use of our Services, including its applicable limitations on damages and dispute resolution. What we collect and how

How does LT Education Abroad Limited my personal information?

We collect personal data directly from you, about you from third parties, such as our marketing affiliates and service providers that are used to verify your identity and prevent fraudulent activities, other users of LT Education Abroad Limited and other clients of LT Education Abroad Limited or clients for the purpose of providing you with LT Education Abroad Limited Services or as part of a client referral program, and automatically as you use our website and services. At this time, use of our Services is only available to users who register for our Services.

We receive personal data about you from third parties, such as bank references, credit reporting agencies, affiliates, other LT Education Abroad Limited users, event providers, and other third parties (for example, entities that help us validate your identity, for purposes of risk assessment, fraud prevention, etc.).

We may combine this information with other information that we collect about you. We, and our third-party service providers, automatically collect the following information about your use of our website and our Online Services through cookies, web beacons, log files, and other technologies (subject to your consent where required by the applicable law): your domain name, your browser type and operating system, the web pages you view, the links you click, your IP address, the amount of time you visit our website or use our services, your activities on our website and the referring URL or the web page that led you to our website. When we collect your information and how we use it

LT Education Abroad Limited. collects your personal data each time you perform any of the following actions and uses it as described:

You do not need to create an account to visit and explore certain features of our website, such as browsing various schools and programs, reading other parts of the website content, or determining your eligibility for certain programs. If you choose to use our website to discover programs for which you are eligible to apply, we collect personal data such as your nationality, country of education, higher education, grading scheme, grade point average, English test score (s) and the disciplines or programs that you are interested in pursuing. LT Education Abroad Limited uses this information to create a list of programs and schools to which you can apply.

Create a student profile and / or apply to an educational program: To apply to an educational program, you (or the recruiting partner or advisor who acts as your legal representative) must create a student profile on our website or application form. The personal data that we collect from your student profile helps us match you with the schools and programs that match your preferences and language level. This information may also be required by the school to process your request. This information may include your first and last name, email address, gender, date of birth, home address and postal address, passport details, marital status, emergency contact information, English language test score (s), educational preferences. (as preferred study destination and educational fields of interest), educational history, volunteer experience and other educational information. During the application process, you have the option of providing additional information, such as documentation of awards and school projects. This information is not required to process your application but is recommended to improve the success of your application. We may use your

profile information and other information about your use of the website (such as search queries or other links that you click) to provide you with personalized school recommendations through the website.

Use an email account: to facilitate your communications with certain schools of interest. Email accounts are only used to apply for educational programs through LT Education Abroad Limited. LT Education Abroad Limited.

Please note that any personal data that you voluntarily post in any public forum will be available to others and you should exercise caution when posting any personal data. Content that you post on sites owned by third parties (such as social media platforms) is subject to the privacy policies of those third parties.

Contact Us: When you contact us with a comment, question, or complaint, you may be asked for information that identifies you (such as your name, address, and a phone number) along with additional information that we need to help us respond quickly to your question or respond to your comment or complaint. We may also retain this information to assist you in the future and to improve our customer service, products, service offerings, events, and promotions.

Our applications are designed to directly connect our users in a secure, transparent, and cryptographic way to the PCI certified payment processor. This helps to ensure that we maintain the privacy of your financial transactions. Payment processor provides LT Education Abroad Limited. a transaction number and a status.

This information is often required for visa applications as proof of program payment, as well as a demonstration of the student's commitment to the selected program. LT Education Abroad Limited. maintains a list of payment processors that we may use to process payments to independent service providers and / or third-party contractors in connection with the Services.

When do we share your information?

We may also disclose personal data when necessary for the establishment, exercise or defense of legal claims, to detect, suppress or prevent fraud, and to investigate or prevent actual or suspected loss or damage to persons or property. When you have engaged a recruiting partner or advisor to submit your application to LT Education Abroad Limited., We may be required, for legal, regulatory and / or compliance purposes, to contact you directly to confirm certain information. provided in connection with your application process.

Where we store your data

All information you provide is stored on our secure servers. All transactions will be encrypted using SSL technology. Where we have given you (or where you have chosen) a password that allows you to access certain parts of our site, you are responsible for maintaining the confidentiality of this password. We ask that you do not share a password with anyone.

Our servers are located mainly in Spain. Many of our service providers are also located outside of Spain. While we use appropriate security measures to keep your information safe, laws elsewhere may differ from those in Spain and authorities in those jurisdictions may access your information in accordance with their local laws.

Safeguards

LT Education Abroad Limited. takes the protection of your information very seriously. We have implemented reasonable administrative, technical, and physical safeguards in an effort to protect against unauthorized access, use, modification, and disclosure of personal data in our custody and control, including limiting access to our database to legitimate users and employment. device encryption and version tracking.

Unfortunately, the transmission of information over the Internet is not completely secure. Your rights

Third party analysis

- Please confirm if we are processing your personal data.
- Give you a copy of that personal data.
- Provide you with other information about your personal data, such as what data we hold, what we use it for, to whom we disclose it, whether we transfer it outside the EEA and how we protect it, how long we keep it, what rights you have, how you can make a complaint, where we obtained your data and if we carry out any automated decision-making or profiling. Our goal is to provide you with all this information in this Policy, although if

You do not have to pay a fee for a copy of your personal data unless your request is unfounded, repetitive or excessive, in which case we will charge you a fee, reasonable amount in the circumstances. We will inform you of any charges before completing your application.

Correction of your personal data

You can ask us to correct any personal data that is inaccurate or incomplete (in most cases, you can make these changes yourself by logging into your account). This is free.

If we have shared the personal data with another person, we will inform you of the correction whenever possible.

If we are unable to process a request to correct your personal data, we will let you know and explain why.

Delete your personal data:

This right is sometimes called the "right to be forgotten". This is not an absolute right, but you have the right to have your data erased, free of charge, under certain circumstances.

You can request that your personal data be erased when:

- It is no longer necessary for the purpose for which it was originally collected or processed;
- We are processing your personal data based on your consent and you withdraw that consent;
- You object to the processing of your personal data and we have no overriding legitimate interest to continue;
- You have been illegally prosecuted;
- It must be deleted to comply with a legal obligation;
- He was prosecuted for offering information society services to a child.

There are some exceptions to this right. If any of these apply, we do not need to delete the personal data.

If we have shared your personal data with third parties, we will inform them of the erasure of your data unless this is impossible or involves a disproportionate effort.

Please note, in relation to such requests, that personal data may be deleted or retained in an aggregate manner without being linked to any identifier or personal data, depending on commercial technical capacity.

Restrict the processing of your personal data:

You can ask us to restrict the processing of your personal data in some circumstances, free of charge. This is not an absolute right. If the processing is restricted, we may store the personal data and retain enough information to ensure that the restriction is respected unless you consent or the processing is necessary in relation to a legal claim or to protect the rights of another person or for reasons of important public interest. , but we cannot continue to process your personal data.

You can restrict the processing of your personal data in the following cases:

- If you dispute the accuracy of your personal data, we will restrict the processing until we have ensured that the personal data is accurate.
- If you object to our processing pending verification of whether our legitimate interests prevail over your interests, rights, and freedoms or in connection with legal proceedings.
- If the processing is illegal but you do not want us to erase your personal data.
- If we no longer need personal data but you need it to establish, exercise or defend a legal claim.

If we have disclosed the data to a third party, we will inform you of the restriction unless it is impossible or requires disproportionate effort. We will inform you if we decide to lift a restriction on the processing of your personal data.

Oppose the processing of your personal data:

You have the right to object to the processing of your personal data at any time. This application will be free. It is not an absolute right, but you can object to us processing your personal data when:

- Based on the reason for legitimate interest; or
- For scientific / historical statistical and research purposes.

We will stop processing your personal data unless we have compelling legitimate reasons for the processing that override your interests and rights, or unless we are processing personal data for the establishment, exercise, or defense of legal claims.

You can ask us to stop using your personal data for direct marketing purposes. We will stop as soon as we receive your request, however we may not be able to implement this for any direct marketing campaigns that are already in progress. There are no exemptions or reasons for us to refuse.

Data portability

This allows you to obtain and reuse your personal data for your own purposes across different services. Applies when the following conditions are met:

- You provided us with the personal data yourself.
- We are processing personal data based on your consent or because it is necessary for the performance of a contract; and
- The treatment it is done by automated means.

We will provide you with your personal data free of charge in a structured, commonly used, and machine-readable format.

Automated decision making and profiling.

You have the right not to be subject to a decision that is based solely on automated processing and that has a legal (or equally significant) effect on you.

We will inform you of any automated decision making that affects you. You have the right to:

- Request human intervention;
- Express your point of view;
- Ask for an explanation of the decision; and
- Challenge the decision.

These rights are not absolute. We may not be able to comply with this request if the processing of personal data is:

- Necessary for us to enter into or perform a contract with you;
- Authorized by law (for example, for the prevention of fraud) and which also establishes the appropriate measures to safeguard your rights, freedoms, and legitimate interests; or
- Based on your explicit consent.

Respond to requests to exercise your rights

We will respond to your request without undue delay no later than within one (1) month after receiving your request, unless it is particularly complicated or you have made multiple requests, in which case we can extend this for two (2) months. We will inform you if we are going to take more than one (1) month to attend to your request. If we have a lot of information about you, we may ask if you can tell us exactly what you want to receive. This will help us process your request more quickly.

In order to comply with your requests to exercise the rights listed above, we will carry out the necessary internal processes to identify you.
